AGREEMENT
BETWEEN THE
DEER PARK
SCHOOL DISTRICT,
ENGEL BERMAN

AND THE Upon a motion by Mr. Centamore, seconded by Mr. Jean-Pierre,

TOWN OF BABYLON the Board of Education unanimously approved the

following Resolution:

WHEREAS, the Board of Education of the DEER PARK UNION FREE SCHOOL DISTRICT has duly held a board meeting on February 4, 2025 consistent with its bylaws, and

WHEREAS, pursuant to a 2014 agreement between Engel Berman (EB) and the Deer Park Union Free School District (the "School District"), EB was to make a donation in the form of a certain parcel of land and \$675,000.00 ("the Donation") to the School District as more particularly described in the agreement between EB and the School District (the "Release Agreement," attached as Exhibit A in file).

WHEREAS, the School District wishes to permit the Donation to be made by EB to the Town of Babylon L.D. Corp. II (the "Town"), rather than to the School District, as more particularly described in the attached letter agreement between the Town and the School District (the "Letter Agreement" attached as Exhibit B in file).

WHEREAS, upon the Donation to the Town, the School District and EB will mutually release each other from liabilities and obligations, all as memorialized in the Release Agreement.

NOW, therefore, upon review of the Release Agreement and the Letter Agreement, and following a vote of the Board members, it is hereby:

RESOLVED, that the Board of Education of the Deer Park Union Free School District approves the terms of the Release Agreement between Engel Berman and the School District, attached as Exhibit A, and,

BE IT FURTHER RESOLVED, that the Board of Education of the Deer Park Union Free School District approves the terms of the Letter Agreement between the Town and the School District, attached as Exhibit B, and,

BE IT FURTHER RESOLVED, that the President of the Board of Education is hereby authorized to execute said Agreements on behalf of the District.
